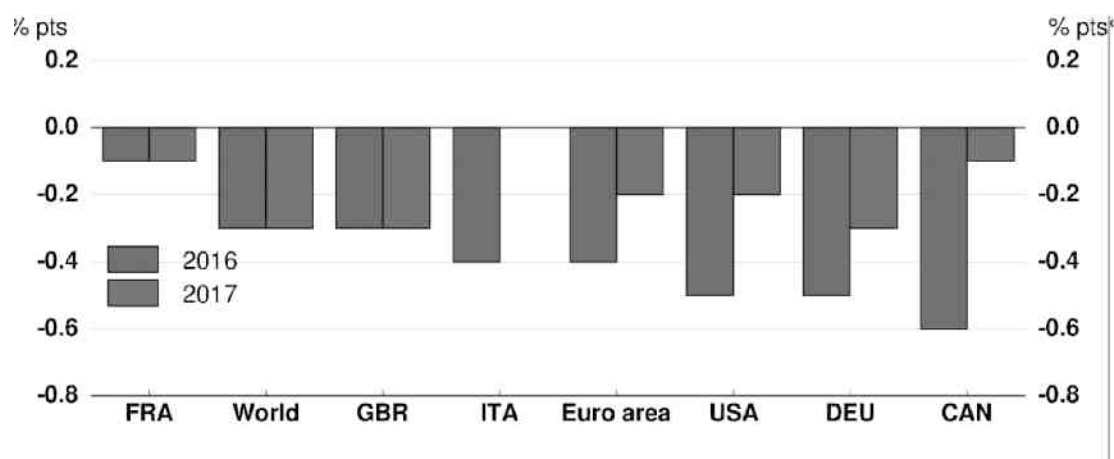

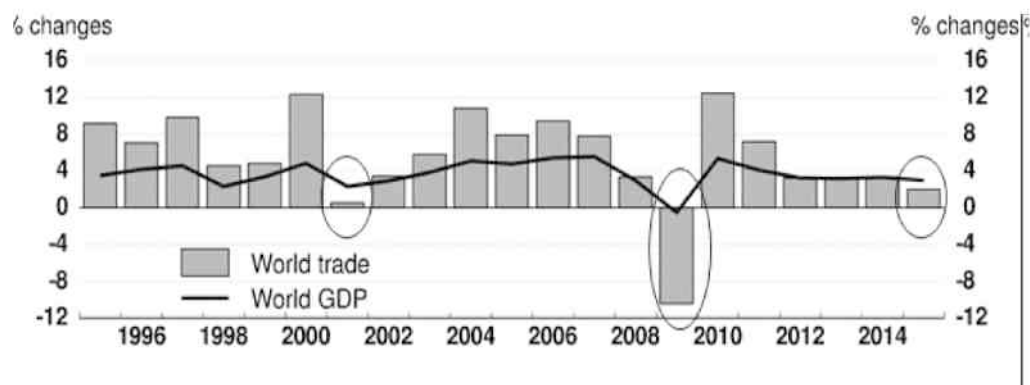

Figure 1 :GDP Growth Forecast Downgrades Since November



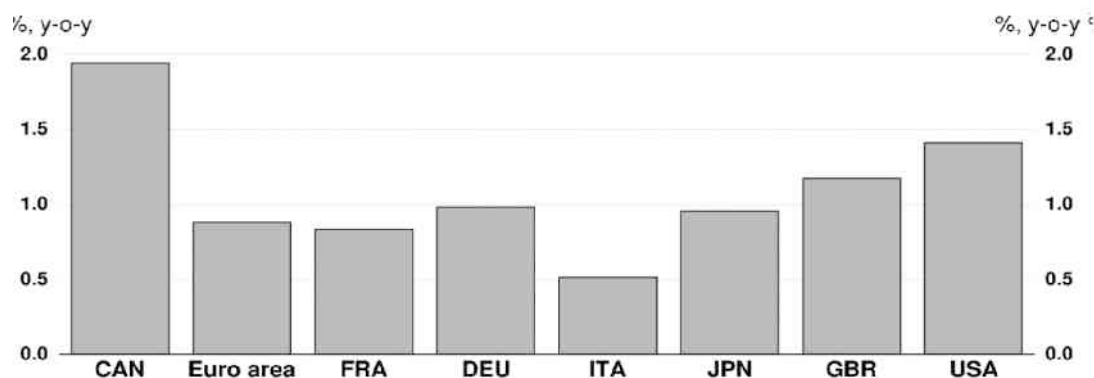

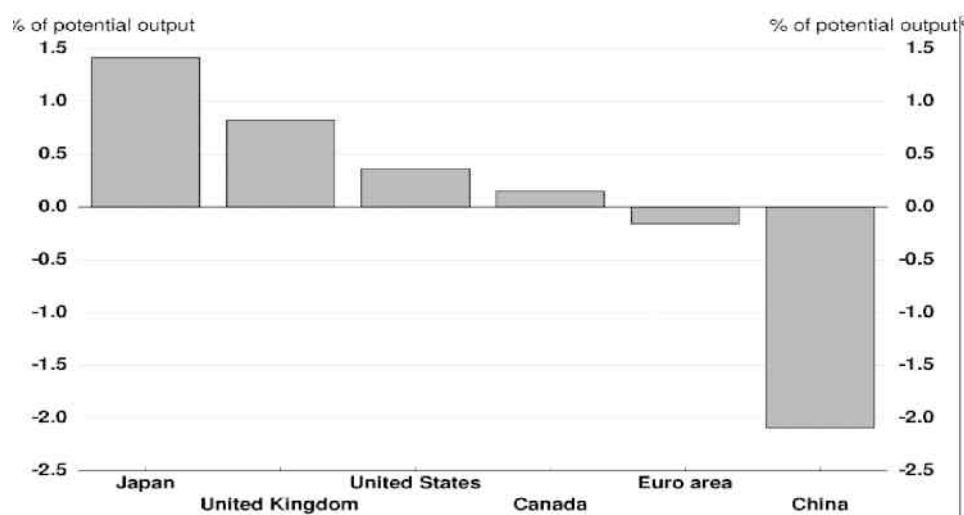
Figure 3 : Low Inflation in Advanced Economies
