Figure 1: Share in GST Base & GSDP





Figure 2: Share in GST Base & Manufacturing GSDP




Figure 3: Manufacturing Gross value addedd (GVA) (in percent of GDP)








**Figure 5: Net Capital Inflows** (US \$ Million)







Figure 6: Agriculture: Real GVA and Real Revenue (Crops: 2014=100)









Figure 8: Profitability and Provisioning of Public Sector Banks (Rs. Billion)
